

## FIELD TRAINER AGREEMENT

I am a NJ Licensed Home Inspector (License #)				
and will be acting as a Field Trainer for NJ Academy of Home Inspectors (NJAHI). I understand that while I				
am not an employee of NJAHI I am acting as an independent contractor. I further understand that as an				
independent contractor I will receive an IRS 1099-MISC form if total compensation for the year is greater				
than \$600. I also understand that I am solely responsible to pay/report any and all taxes on any compensation				
earned. Compensation will be earned per the below compensation table and will be paid at the end of each				
month. Please be advised the compensation table is subject to change due to the needs of the business.				
Should the compensation table be changed for any reason you will be notified in writing.

I also understand that while I am a working as an independent contractor, I represent NJ Academy of Home Inspections. I will conduct myself in a professional manner when providing field training for any and all students. I also understand that while the student can help during the inspection the student(s) are there to learn, and I will provide instruction to them during the inspection.

I understand that while conducting field training, I will not put any students (or allow students to put themselves) in an unsafe situation. I understand that it is NJAHI's policy to NOT allow students to climb ladder(s) and if I allow students to climb ladder(s) during an inspection, I will take full responsibility for the student's safety.

I understand that as the Field Trainer I have sole discretion to remove a student from an inspection for any reason. I understand that at the completion of each inspection I will send a copy of the home inspection report to <a href="mailto:training@nj-ahi.com">training@nj-ahi.com</a>. All reports sent to NJAHI will **ONLY** be used as a training aid for the student(s).
